

RESOLUTION NO. 2012 - 03

A RESOLUTION INSTITUTING TEMPORARY PARKING RESTRICTIONS AND TRAFFIC CONTROLS DURING THE 2012 THOMAS THE TANK ENGINE EVENT

WHEREAS, the governing body has received a request from the Midland Railway regarding parking and traffic issues and proposed solutions surrounding the entity's hosting of the 2012 "Day Out with Thomas" event; and

WHEREAS, the Midland Railway, the City Staff, and the Governing Body agree that certain temporary measures on behalf of the city would be useful in dealing with parking and traffic issues during the 2012 Thomas the Tank Engine "Day Out with Thomas" event; and

WHEREAS, the Midland Railway members will install and remove all signs.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Baldwin City, Kansas:

- Section 1. A temporary "No Parking" zone shall be in place along the west side (South bound) of Lawrence Street from High Street to South Street beginning 12:00 A.M. Friday June 1, 2012 and ending 11:59 P.M. Sunday June 3, 2012; and again beginning 12:00 A.M. Friday June 8, 2012 and ending 11:59 P.M. Sunday, June 10, 2012.
- Section 2. A temporary "No Parking" zone shall be in place along both sides of High Street from Lawrence Street to 13th Street beginning 12:00 A.M. Friday June 1, 2012 and ending 11:59 P.M. Sunday June 3, 2012; and again beginning 12:00 A.M. Friday June 8, 2012 and ending 11:59 P.M. Sunday, June 10, 2012. This no parking shall be north side only on Saturday, June 2, 2012 to accommodate parking for the city-wide garage sale.
- Section 3. A temporary "No Parking" zone shall be in place along both sides of Main Street from High Street to College Street beginning 12:00 A.M. Friday June 1, 2012 and ending 11:59 P.M. Sunday June 3, 2012; and again beginning 12:00 A.M. Friday June 8, 2012 and ending 11:59 P.M. Sunday, June 10, 2012. This no parking shall be north side only on Saturday, June 2, 2012 to accommodate parking for the city-wide garage sale.
- Section 4. A temporary "No Parking" zone shall be in place along both sides of College Street from Main Street to Lawrence Street beginning 12:00 A.M. Friday June 1, 2012 and ending 11:59 P.M. Sunday June 3, 2012; and again beginning 12:00 A.M. Friday June 8, 2012 and ending 11:59 P.M. Sunday, June 10, 2012. This no parking shall be north side of College and Lawrence

Streets and the east side of Main Street only on Saturday, June 2, 2012 to accommodate parking for the city-wide garage sale.

- Section 5. A temporary "One Way" sign for traffic control on Miami Street from College Street north to the first alley beginning 12:00 A.M. Friday June 1, 2012 and ending 11:59 P.M. Sunday June 3, 2012; and again beginning 12:00 A.M. Friday June 8, 2012 and ending 11:59 P.M. Sunday, June 10, 2012. Traffic will be southbound only.
- Section 6. A temporary "One Way" sign for traffic control on the alley from Main Street to Miami Street beginning 12:00 A.M. Friday June 1, 2012 and ending 11:59 P.M. Sunday June 3, 2012; and again beginning 12:00 A.M. Friday June 8, 2012 and ending 11:59 P.M. Sunday, June 10, 2012. Traffic will be westbound only.
- Section 7. Miami Street from Ottawa Street south to the first alley shall be temporarily closed to all beginning 12:00 A.M. Friday June 1, 2012 and ending 11:59 P.M. Sunday June 3, 2012; and again beginning 12:00 A.M. Friday June 8, 2012 and ending 11:59 P.M. Sunday, June 10, 2012.
- Section 8. This Resolution is intended to be temporary due to the fact that different and/or additional parking and traffic restrictions may be recommended in future years by the City, the Public Health & Safety Committee, and/or the Midland Railroad as sponsors of the Thomas the Tank Engine "Day Out with Thomas" event.
