

RESOLUTION NO. 2013-30

A RESOLUTION EXEMPTING THE BALDWIN CITY SWIMMING POOL FROM PROVISIONS OF HOUSE BILL NO. 2052 UNTIL DECEMBER 31, 2017.

WHEREAS, provisions of House Bill No. 2052 allow municipal buildings to be exempt for an additional four years; and

WHEREAS, the City of Baldwin City has created a security plan for the Baldwin City Swimming Pool in accordance with sections of House Bill No. 2052.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Baldwin City, Kansas:

Section 1. The following building is hereby exempted from the requirements of Kan. Sess. 2013 Ch. 105, Sec. 2 (i)

- Baldwin City Swimming Pool -317 Freemont Street

A TRACT OF LAND LOCATED IN THE BLOCK KNOWN AS GROVE PARK PLATTED IN THE CITY OF BALDWIN CITY, DOUGLAS COUNTY, KANSAS, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE NORTH LINE OF THE SAID BLOCK 110 FEET WEST OF THE NORTHEAST CORNER OF THE SAID BLOCK; THENCE SOUTH TO A POINT 110 FEET WEST AND 100 FEET SOUTH OF THE NORTHEAST CORNER OF THE SAID BLOCK; THENCE SOUTHWEST TO A POINT 200 FEET WEST AND 250 FEET SOUTH OF THE NORTHEAST CORNER OF THE SAID BLOCK; THENCE WEST TO A POINT 370 FEET WEST AND 250 FEET SOUTH OF THE NORTHEAST CORNER OF THE SAID BLOCK; THENCE NORTHEAST CORNER OF THE SAID BLOCK; THENCE NORTH TO A POINT ON THE NORTH LINE OF THE SAID BLOCK SAID POINT BEING 370 FEET WEST OF THE NORTHEAST CORNER OF THE SAID BLOCK; THENCE WEST TO THE POINT OF BEGINNING, CONTAINING 1.34 ACRES

Section 2. The exemption is based on the analysis of the security plan completed on this building and the determination of the governing body that safety is sufficient to continue the ban on concealed weapons from this building.

Section 3. A security plan has been developed for the building being exempted which supplies adequate security to the occupants of the building and merits the prohibition of the carrying of a concealed handgun as authorized by the Personal and Family Protection Act. The prohibition shall continue until December 31, 2017.

Section 4. A copy of the security plan shall be maintained by the city clerk and will be provided to the Kansas Attorney General or local law enforcement upon request. The security plan is not subject to disclosure under the Kansas Open Records Act.
